# News You Can Use! News You Can Share!

Greetings! Fall is here! And that means the Medicare Annual Enrollment Period is also right around the corner, October 15 thru December 7.

2025 will be another unique year! As a result of the Biden-Harris Administration's Inflation Reduction Act, Part D Drug Plan benefits must limit the Member's Annual Out of Pocket cost share to \$2000 per year. In addition, there will no longer be a Donut Hole! And Medicare's new Prescription

Payment Plan will begin for 2025. More on this later.

#### 19 Years!

### **ACA Plans (aka Obamacare)**

The Affordable Care Act is still the Law of the Land. **Open Enrollment** is November 1 thru January 15. But to get a January 1 Effective Date, you must apply by December 15. Applications submitted December 16 thru January 15 will receive a February 1 Effective Date. After January 15, a Qualifying Life Event is required to be eligible for a Special Enrollment option.

Remember with Obamacare, your monthly premium is based on the subsidy you receive, which is based on your estimated annual income you provide. And when you file your taxes, the IRS compares your actual income to your estimated income, and you either receive additional subsidy, or you may have to pay some, or all of it back!

## **Medicare Plans are Changing!**

If you have a Medicare Advantage Plan (Part C), or stand-alone Prescription Drug Plan (Part D), you should have received the **Annual Notice of Changes** from your current Insurance Company in September. If you have a Medicare Advantage Plan, you should see some benefits for 2025 increasing, but some will decrease or remain unchanged.

In the Biden-Harris Administration's *Inflation Reduction Act*, Part D Drug Plan benefits must limit the Member's Annual Out of Pocket cost share to \$2000 per year. As a result of the increased cost on Insurance Companies to implement this, many Part D Stand-Alone Plans will have higher premiums and drug deductibles, up to \$590 on some plans. And some Medicare Advantage Plans will also be adding some Drug Deductibles, as well as higher Copays and fewer "extras".

#### **No More Donut Hole!**

The Part D Prescription Drug benefits for 2025 will no longer have the Donut Hole, aka the Coverage Gap. And as previously mentioned, the maximum out of pocket for prescription drugs will be \$2000.

# **New Prescription Payment Plan**

If you use low cost, generic drugs, you probably won't need this. But if you have some expensive medications and your Plan has a large deductible, then you might want to consider the new Prescription Payment Plan. This will spread the cost of your drugs over the year thereby avoiding a big payout in one or two months.

Your insurance company will determine your monthly payment and send you a bill. Then, there will be no charge when you pick up your prescriptions. You can enroll or disenroll at any time by contacting your insurance company.

# **State Employees & Retirees**

Open Enrollment for State Employees & Retirees is September 30 thru October 25.

If you are currently enrolled in a Humana Group Medicare Advantage Plan, it will renew automatically.

If you are currently enrolled in the Medicare **Base Blue Cross PPO 73-30 Plan, you will be moved** to the Humana Group Medicare Advantage Plan unless you call and request to keep the 70/30. Also note the 70/30 Plan will be administered by Aetna in 2025.

If you are not yet on Medicare, refer to the Decision Guide you receive from the State.

If you want to change your Plan, you will need to contact the State between September 30 and October 25. Call the Enrollment Support Center at 855-859-0966, Monday through Friday, 8:00 am – 10:00 pm, and Saturday, 8:00 am – 5:00 pm.
